

2024 Tuition Payment Policy

Tuition and fees are due and payable on the first day of the month prior to care. Check payments should be placed inside the locked tuition box on the wall outside of the WLT office. Card and bank transfer payments must be made through brightwheel. Payment reminders are sent out 3 days prior to the first of the month through brightwheel. *Example: Tuition for the month of January is due January 1.

Any accounts with balances due as of the 11th of the month will be charged a \$30 late fee. Tuitions must be paid by the 10th to avoid the late fee, or payment arrangements made with the Director. If payment arrangements are not kept, the late fee will be applied.

Payment plans are subject to approval by the WLT Oversight Committee.

If a payment plan is not arranged prior to the 28th of the month, the child will not be eligible to return to class until a payment plan has been agreed upon, OR full payment received.

Siblings enrolled will receive a 10% discounted rate for the preschool portion of the day. The discount does not apply to AfterCare rates. Further, siblings will also not be eligible to begin care if there is a balance on the account.

Receipts and account statements are accessible through brightwheel.

Year end statements are accessible through brightwheel by January 31 each year.

Additionally, the month of August and the first month of attendance for newly enrolled children (if applicable) are the only prorated months of care. There will not be any further adjustments made to any additional tuitions, including May (end of the school year) or for inclement weather cancellations. *If SPS is closed for inclement weather, WLT will be closed also.

Non-refundable registration fees are collected at enrollment time each year and serve as your commitment to the acceptance of your child's space. Preschool and AfterCare have separate registration fees. We are also non-profit organization.

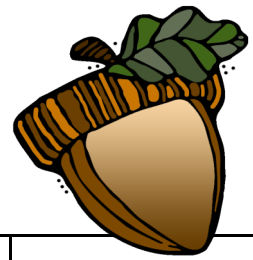
